**Subject: Corrigendum w.r.t. age relaxation to Ex-Servicemen and
Notice for inviting Application Forms for only Ex-Servicemen from 28.12.2016 to 07.01.2017**

This is to inform to all concerned that the upper age-limit shall be relaxed by the length of military service increased by three years in the case of Ex-servicemen and Commissioned Officers including Emergency Commissioned Officers / Short Service Commissioned Officers subject to the condition that-

- (i) The continuous service rendered in the Armed Forces by an ex-servicemen is not less than six months after attestation; and
- (ii) The resultant age after deducting his period of service from his actual age does not exceed the prescribed age-limit by more than three years and also, subject to usual conditions which have been prescribed vide Notification No. 39016/10/79-Estt. (C) dated 15.12.1979 of Government of India, Ministry of Home Affairs, Department of Personnel & Administrative Reforms.

The relaxation of upper age-limit prescribed above is applicable only to Commissioned Officers including ECOs/SSCOs as have been / are released from Military Service either-

- (i) On completion of assignment otherwise than by way of dismissal or discharge on account of misconduct or inefficiency; or
- (ii) On account of physical disability attributable to Military Service or on invalidment after putting in at least five years, Military Service;

And that the relaxation in upper age-limit is not available to serving Commissioned Officers.

Accordingly, for only Ex-Servicemen, applications are invited against the aforesaid recruitment advertisement dated 26.11.2016 for the posts of Chief Manager and Deputy Manager from 28.12.2016 to 07.01.2017. The last date of receipt of Application Forms is 07.01.2017 (till 6.00 PM). However, all other Guidelines and Terms & Conditions in r/o aforesaid advertisement dated 26.11.2016 remain the same and the age, qualification and experience will be counted from the earlier last date of receipt of applications i.e. 12.12.2016.

An Undertaking as per **Annexure-A (format enclosed)** has to be sent along-with the application forms in addition to all other documents prescribed as per the detailed advertisement dated 26.11.2016, failing which the candidature will be rejected.
