MY NAME IS MALOTH SUMA Scheduled Tribe(ST) ENTREPRENEUR, I HAVE SANCTIONED A TERM LOAN AT UNION BANK OF INDIA TO PURCHASE EQUIPMENT, I AM ELIGIBLE FOR SCLCSS SUBSIDY AND REGISTERED UNDER UDYAM REGISTRATION, AND I HAVE APPLIED ACCORDINGLY, BUT BANK NODAL AGENCY RAISED QUERY AND STOPPED MY SUBSIDY CLAIM, ASKING THAT "" AS TELEPHONICALLY CONFIRMED BY NSIC OFFICIAL, IF LOAN IS SANCTIONED IN THE NAME OF INDIVIDUAL THEN SUBSIDY CANNOT BE CLAIMED IN THE NAME OF FIRM"" We have applied in our own name after taking Udyam registration(MSME Certificate). Individual called as both Proprietorship firm or Sole Proprietor or Individual.

Defination of Sole Proprietorship: A Sole proprietorship is an enterprise owned exclusively by one natural/individual person and in which there is no legal distinction between the owner and the business entity. The entrepreneur exercises his activity without having created a distinct legal person.
