

Minutes of Meeting

A second meeting was organized by the NSIC with the Industries Feedback Committee on deliberation of Single Point Registration Scheme (SPRS) in the Board Room of NSIC, Head Office on 5th January 2017. The meeting was chaired by Director (P&M), NSIC and the followings were present in the meeting:-

Director (P&M) of NSIC welcomed all members of Industries Feedback Committee & apprised about the recent developments in MSME sector and action initiated after the last meeting. The Director (P&M) also apprised the committee members about the proposed changes in the SPRS Application Form with an attempt to make it more customer friendly for MSEs. Director (P&M) also informed the Association's members that MSEs who are availing the benefit of Public Procurement Policy must get themselves registered with MSME Data Bank, being operated by NSIC, under SME Division, Ministry of MSME, in order to create proper database of MSEs which are making supplies to CPSUs. Therefore, NSIC has made the provision in the proposed Application Form to obtain the confirmation from the applicant MSE unit that they have made the entry in databank of MSME.

Director (Fin), has also explained the rationalization of the processing fee of Single Point Registration Scheme which were recently issued for the benefit of MSEs.

A power point presentation on features & simplification of Application Form of Single Point Registration Scheme was made before the Association's members. We have also offered the comments/suggestions on the simplification of Application Form from the Association's members.

It was also informed by IIA & Okhla Industrial Estate Association that they are going to organize awareness programme (exact date to be finalized) for their members in Okhla and requested that some official may please be deputed to attend the awareness programme and explain the schemes of the Corporation and the same was agreed.

The following suggestions/comments were made in the meeting:-

1. **Indian Industrial Association** commented that the field officers conducting Awareness programmes on various schemes of NSIC including Single Point

Registration with Associations should make an attempt to associate at least 5 attendees to be associated with NSIC.

2. **Badli Industrial Estate Association** suggested the following changes / modifications in the Application Form:

- (a) Entrepreneur's Memorandum Part-II issued by the DIC should be made optional.
- (b) The name, address & email of the Association, if the applicant MSE unit is member may also be mentioned. It is optional to the MSE unit.
- (c) Since we are obtaining the category of the unit in the proposed Application Form, the same should also be mentioned on the Enlistment Certificate.

3. **IIA & Okhla Industrial Estate Association** has suggested the following:-

- (a) The NSIC should consider to issue the Enlistment Certificate for 5 years instead of 2 years. It was informed to them that to check the performance of the MSE unit and their viability, corporation has already reduced the time period from 3 years to 2 years. He agreed that the existing system is good and in the interest of the MSEs.

4. **TANSTIA Association** has informed that their members are facing the following problems while participation in tenders:-

- (a) The State Governments are not extending the benefits as per Public Procurement Order 2012 for MSEs.
- (b) Southern Railway is not extending the benefits to their members while participating in the service tenders

It was requested that NSIC should take up the issue with State Governments and Railways. We have informed that Railway Board had already issued the guidelines to all Railways to extend the benefits to the MSE units in the service tenders. A copy of the Railway Board order will be mailed to all members shortly so that they may take up the issue locally.

TANSTIA also wanted their views on MA Scheme to be considered.

5. It was also suggested by the all the Association members that Head Office may also conduct stakeholder's meetings at regional level so that at local level also the Associations/Stakeholders may get the chance to bring the problems/suggestions and ascertain the ground realities being faced by the MSEs with a view to get them addressed.
6. It was also agreed to rotate the members in different stake holders meetings to obtain wider views.
7. It was also agreed that the Minutes will be displayed on the NSIC website which can be seen by all associations & MSME units.

Director (P&M) thanked to all the members of Associations for attending the meeting. It was informed that the Corporation is also conducting meetings of the stakeholders on the other schemes and if they have any suggestions they may forward the same for deliberation during such meetings.
